I understand that this Release and Hold Harmless Agreement is a waiver of any and all liability(ies). I further warrant I am of legal age to enter into this agreement on behalf of myself or as guardian/parent of minor child.

I further voluntarily agree and warrant to Release and Hold Harmless Melina Prince and Mon Cheval Friesians and Mon Cheval Training Center, LLC, L and M Enterprises, LLC, its agents and employees (which included MCTC owners, officers, trainers, laborers, instructors, other agents whether employees, contractors or volunteers), from any liability whatsoever including, but not limited to, any incident caused by or related to said equine professional's negligence, relating to injuries known, unknown or otherwise herein disclosed; including but not limited to, injuries, death or property damage from: mounting; riding; dismounting; walking; grooming; feeding; use of horse in barn; paddock; trails; or riding arenas, in any capacity; falling of horse whether horse is bucking, flipping, spooked, jumping; or my failure to understand any of the equine professional's directions relating to my riding or otherwise use and control, or lack thereof, of my horse or the horse I have been assigned to. I understand the potential dangers that I could incur in mounting, riding, walking, boarding, feeding the said horse(s); including but not limited to, any interactions with other horses. Understanding those risks I hereby release Melinda Price/Mon Cheval Friesians/Mon Cheval Training Center, LLC,L and M Enterprises, LLC, its agents and employees (which included MCTC owners, officers, trainers, laborers, instructors, other agents whether employees, contractors or volunteers), from any liability whatsoever in the event of injury or damage of any nature (or perhaps even death) to me or anyone else caused by or incidental to my (or said child) electing to mount and ride a horse owned, leased, or operated by equine professional(s) and/or Melinda Price/Mon Cheval Friesians/Mon Cheval Training Center, LLC,L and M Enterprises, LLC, its agents and employees (which included MCTC owners, officers, trainers, laborers, instructors, other agents whether employees, contractors or volunteers).

I recognize, and confirm that I have disclosed all prudent information associated with my/my child's behavior, fears, and previous riding experiences to Melinda Prince/Mon Cheval Friesians/Mon Cheval Training Center, LLC, at the bottom and back side of this Agreement.

The Rider fully understands that equine activities are considered dangerous and can result in serious injury and even death to persons engaging in these activities. Horses are subject to fight or flight instincts when

placed in a situation in which the equine(s) feels threatened. No amount of training can eliminate this instinct and thus the equine(s) is to be considered a possible danger to the Rider and to those persons engaging in all activities involving the equine(s). The rider has been notified about the proper use of riding apparel and equipment for safety. This includes, but is not limited to, an approved riding helmet either on or while handling any horse(s).
